

**STUDENT PARKING RULES  
(PLEASE KEEP FOR YOUR INFORMATION)**

1. To apply for a parking permit, students must bring their license, vehicle registration, no-fault insurance card and safety check for verification.
2. Once approved, Kalaheo High School and/or the State of Hawaii will not be responsible for any damages or loss of property sustained to the car while on school grounds. This includes break-ins, vandalism, hit and run incidents, theft, and all others except when hit by State vehicles. This becomes a police matter.
3. If improperly parked (double parking, blocking entry ways, parking in reserved stalls or service zones, or parking without a permit), the vehicle will be towed away at the owner's expense (Section 298-26 HRS), and/or traffic citation issued by the Honolulu Police Department.
4. Infraction in parking and parking lot rules can result in the student's suspension and/or revocation of the parking permit. This includes speeding, smoking or drinking alcohol in cars, loitering in/around vehicles during class hours and all other infractions of civil laws or school rules.
5. Students with scheduled appointments during the school day **MUST PARK OFF CAMPUS** and not in the student parking lot.
6. **THERE WILL BE A CHARGE OF \$20.00 TO COVER THE COST OF THE PARKING PERMIT FOR VEHICLES AND \$10.00 FOR MOPEDS. THIS PERMIT MUST BE HUNG ON THE REAR VIEW MIRROR** only when the vehicle is parked on Kalaheo's campus (Moped drivers must be able to show permit upon request.). This permit is for the student parking area only. There will be a \$10.00 charge to replace lost parking permits for cars and a \$5.00 charge to replace lost parking permits for mopeds. Rev. 7/15
